Scholarship students receive room, board, tuition, laptop computers, school uniforms, English classes, eye care and dental care. Twenty-three students live in our dormitory in Battambang.

English Language Program. We offer after-school English classes to 400 3rd-12 grade students in Prey Touch Commune. Students are asked to make a \$10 donation per year to pay for books and supplies.
